8. Major Grant

 Recommendation: That the Clubs Committee considers the major grant application for \$2250 made by Adelaide University Engineering Society (AUES).

Luke: They had to order the shirts for them to arrive in time. They had to purchase the shirts. Mentioned to Jesse if we could help with the next one because grants cannot be paid after the shirts were already paid for. The major grant is to go towards food for the event, an industry night.

Katherine: \$2750 for all of the food costs.

Luke: Believes it has a campus impact.

Katherine: We are hoping for 300-400 people in attendance. Many sponsors are on board for the event.

Kate: Major grants have to go toward a one-off event that would appeal to everyone on campus. This is potentially setting a poor precedent.

Luke: This would certainly be a one-off. I am pretty keen for the Clubs Committee to support it.

Kate: Is there an invoice or a budget? We cannot give the money without any sort of evidence. They have maybe dropped the ball because they haven't been organised behind the scenes.

Katherine has the invoice for food and drinks.

Kate: At the very least, highlight the required funds.

Billy: Would have benefitted from time to consider it. The event is sponsored by all these companies. Is the event trying to make a profit?

Katherine: If we take away the alcohol limit, food will still be in that limit.

Luke: I didn't want the event to go past and then we are unable to support AUES because they would have already spent the money. If they are managing to raise revenue internally, that is a good thing, but that doesn't mean they cannot apply for a major grant.

Simone: We need to see the work behind the Major Grant application, not sufficient by itself.

Katherine: Marketing has been spread to all campuses; organisations employ people from all faculties.

Simone: Need to follow due process, some obvious conflict of interest.

Kate: We could have followed our normal process with this one, we could have had the ball rolling last year when we met with some of the members from AUES. Issues may have been avoided if we followed process.

Luke: Ultimately, instead of approving right now, let us note that they have applied for it prior to the event, and maybe we should consider it noting their exceptions.

Kate: Not good timing since I am on leave, some programs starting at YouX next week, so possibly unable to meet them.

Luke: Let's get Jesse to fill out the major grant / note how the event will satisfy the grant criteria, and we will pass it by Tuesday.

Billy: We could think about it over the weekend.

Kate: If it is the process of a Major Grant, they will need to meet with us. You will need to outline in an email so Clubs Administration know what to do.

Luke: Get AUES to assess the event against the Major Grant criteria, and based on that, Clubs Committee will have a circular resolution prior to Tuesday.

Kate: Standard BBQ format would not apply, but if your BBQ was themed, it could count as a major grant. Can they do something to make the industry night unique?

Tabled. Luke will get in touch with Jesse.

8.1 Ten-Pin Bowling Club EOI

Billy: Applicant is keen to operate the Club within YouX, rather than AU Sport. YouX more focused on social Clubs. He is worried that Sports will not attract the same crowed. Want to get it cemented whether he can start it as a YouX Club, or why not.

Kate: Sport strongly believe it is better suited to their format, the email highlights their decision.

Luke: Ten-Pin Bowling while considered a sport, can be much social. It would work much better under our banner.

Simone: Sport noted they do not exclusively represent competitive sporting clubs, as they have expanded to include social clubs.

Luke: Applicant would rather be affiliated with us. If we do not approve, he might drop the idea.

Simone: Reinforcing the separation between the Ten-Pin Bowling Clubs.
