Oscar: we do not have to listen to you Habibah. You can be invited to speak by the Chair, but you have to negotiate it with the Chair.

Luke: If you want to speak on the issue, you need to provide me with sufficient time. We all have different time schedules. Can you please stay outside the meeting, and when we get to that point in the meeting, we can invite you in. After which, we can invite you to leave while we will have a civil discussion. Not common precedence – in future, we need you to email with more punctuality.

Habibah is happy with those conditions and will leave the room. She wants to be promised that she will be let back into the room.

Habibah is invited back into the room.

Habibah: Believes they should be denied official registration. It is an Australian Zionist lobby group pretending to be a safe place. There is a separation between Zionism and Judaism and their beliefs. Arab students and staff, Palestinian and Muslim students and staff will be in danger. Obvious on *On Dit* page since they are receiving hate, Zionists are commenting bad comments. Believes they are affiliated with and supporters of AUJSA.

Luke: Why is it bad that an organisation points out antisemitism? How do you know that these commentors are members?

Habibah doesn't know of the details of membership. She believes the organisation is all Zionists. They refuse to condemn Israeli war crimes. Not saying we should never have a Judaism Club as a safe space, but that AUJSA should just be denied affiliation. They will destroy campus culture. AUJSA president is labelling everything as antisemitism. They have sent death threats to *On Dit*.

Luke: On what grounds are you claiming that they are affiliated?

Habibah: Go onto Facebook page, scroll through the comments, shows how they are a financial supporter. Zionism threatens the lives of students and staff. It is separate from Judaism.

Luke: Point has been made; committee needs to discuss the decision. People can be loosely affiliated.

Habibah: More so about people going to regular meetings, regular promotion on media etc.

Luke explains circular resolution to Habibah. Habibah wants it to be tabled for the next meeting.

Luke: the way you are acting is not helping your case. If you feel strongly about this, appeal to the committee's sense of reason, please leave the room. Anything beyond a day before the meeting is reasonable. *Habibah leaves the room.*

Meeting moves in-camera at 12:44pm, and moves ex-camera at 1:10pm.

ACTION: That there is a need for Jewish Students Club, which will be communicated to Jonathan via Luke. Current application tabled pending discussion with Jonathan. To be reconvened at earlier convenience.

Moved: Ivan Seconded: Oscar Motion carries. 4. Recommendation: That the Clubs Committee approves the Expression of Interest submitted by the proposed Postgraduate Association of Social Sciences

Ivan met with one of the potential executive members, and he said that there is not enough steam to make it a revival of Social Sciences Club, rather than making for Postgraduate Association of Social Sciences. Around 15-20 students, but when talking about the degrees, well over 100 students. Supports the Club but would be a better idea if part of the broader Social Sciences community.

Oscar: Would provide greater benefit for students if they amend.
