82 responses, 81 during the consultation period. 91% voted against the change to membership numbers. Written responses vary in their argument.

Kate's final recommendation is to change the student and staff membership required from 50% to 51%, to make it a majority.

80% rather than 75% easier to administer.

Do Clubs think that if they don't meet this requirement, they will get de-registered? Perhaps misinterpretation of the survey or the intent behind it. Is there any point in implementing it once we have the feedback against it. Focus

group?

Decision to not change drastically for now, just to 51% to meet the majority requirement - will be suggested to the Board at the next meeting. Tabled.
