Oscar mentions new amendment about membership which the Board has approved, that student and staff percentage must be 51%. He is disappointed with Ivan's 'misrepresentation' of the Clubs Survey in the Network. Ivan believes that the discussion of the Clubs Committee has not been made accessible to students. Clubs etc.

Ivan wishes to change the EOI process, to speed it up.

The 2022 Clubs Committee wishes the best for the 2023 Clubs Committee.
