6. Office Bearer Reports

6.1. President

Aiden notes that it has been a long year with many amazing moments, taking a moment to thank those who have been around over the past four years he has spent in council. He shares that OnDit is doing a nostalgic article for the Universities final year, for which he has submitted his presidents report.

Aiden notes that the food pantry's addition of fresh food has seen great success this year, with it being hosted weekly – a mega food run will be held this Wednesday at the hub. So far more than \$7,000 has been raised.

8. General Business

Aiden asks if there is any other matters to raise.

Aiden mentions that he engaged with IMO a lot this year for student consultation – and that consultation took place between everyone involved. The May and September updates have helped students, which is good – however unfortunately it didn't continue, that so much was going on and so it ended, but overall was positive. Letter to DVCSES study plans should've been out September according to latest info but now its almost November.

Council raises concerns and members making various comments about their experiences with study plans.

Aiden states that students are disappointed that plans are not out, and so hopefully this improves soon. Since September the 8th, its been very busy and so no information has been received from the Uni.

Aiden asks if anyone knows when enrolment will start?



Adrian says that they said enrolment will open in Q1 2026 or Q4 2025.

Aiden says we are already very far into Q4 2025, so hopefully it opens soon.

Aiden asks if anyone has seen course outlines for next year?

Members of council have not.

Samoda shares that they have space for it but have not provided proper/complete outlines.

Adrian shares that he has just opened University of Adelaide student portal which shows the enrolment checklist has opened for 2026.

Nick Li shares that there are problems with his study plan with issues to go to the officer – as no physical place has been provided to visit until November 30 – a long time after the study plans are received.

Aiden thanks Nick as Aiden is unable to see any communications due to graduating at the end of this year. Aiden notes that study plans are a big problem and invites any other observations.

Samoda shares that last week she received an email with the enrolment checklist which stated that December 1st enrolments will open for every student.

Aiden thanks Samoda.

Student Study Plans are a key concern of council.

Adrian shares that the info he has right now was not in an email and was only found by opening the site and checking at this current time.

Samoda says the email included extra information regarding the process.

Aiden asks if there is any other business to discuss.

This advice will also go to the YouX Board, which will hopefully be passed and referred to the AUSA transitional board for the new SRC constitution.

Further, it took long for the AUSA constitution to be formed, and so it will likely also take a long time to decide how the new SRC will be formed – Aiden is unsure how this will go – however is optimistic. There are significant cultural differences between both sides of the negotiation so Aiden will continue to try his hardest to bring a harmonious environment at the new Council – even among factional politics – student service should remain the main most important focus.

RE: Study plans for 2026 - request for revised timeline, enrolment communications, and student support arrangements

I write on behalf of the University of Adelaide Student Representative Council (SRC) to seek clarity regarding 2026 study plans, their expected rollout, and related student communications and support in light of the University merger.

Background

Earlier this year, I engaged closely with Vanessa, Mel, and Courtney from the IMO, with mutual updates flowing both ways. Those exchanges covered:

- (i) the "hot topics" raised by students, clubs, or in Council;
- (ii) burning questions and assurances sought; and
- (iii) matters affecting academic success and student life.

This dialogue supported transparent, informative engagement at Council meetings and in broader communications to students. For example, during the recent "Save Our Lectures" campaign, amplified by media coverage, our consultations and the concerns we relayed led to the University amending its wording to be more specific, improving student understanding and reducing ambiguity to avoid misunderstandings as such from happening in the winder student body.



Council minutes note that, although the University had stated its position on lectures before students raised the issue at Council, the wording was perceived as vague and did not provide the assurances sought. This risk has then developed and fueld some of the earlier grassroot campaigns.

I highlight this example because Council often serves as the bridge between the University and students on matters of concern. Lectures were one such matter; currently, study plans are the recurring theme.

Recent communications with the University

On 15 August 2025, a brief slide was provided to Council and students with information approved for sharing with the wider student body. This was the latest information received by Council from the University however that slide did not mention any change to the study-plan timeframes on which students had been relying under the University's last advice.

That piece of communication released to council namely, a three-phase approach, with the third batch release scheduled between August and September 2025 (as per the slide approved and provided to Council on 15 March 2025). Council and concerned students have continued to rely on that information as the most up-to-date position.

We further note that check-ins with AU staff appear to have ceased on 8 September 2025 due to competing demands. No further updates specific to study plans have been provided to Council since then. These engagements had been effective and informative, and we acknowledge the team's contributions to student consultation.

Council meeting of 13 October 2025

The key issue the Council believes is the lack of updated information and effective dissemination.



At this meeting, external students and Officers of the Council raised concerns that they have yet to hear back from the University, and this frustration was echoed by several Council officers who are also transitioning to the new University. Students identified the following immediate impacts:

- Uncertainty about 2026 enrolment timing (Uni Adelaide historically opens enrolments in early December).
- Limited visibility on courses and course outlines, including popular electives with scarce places.
- Planning constraints for exchange, reduced load, and other variations.
- Need for clear, equitable enrolment advice (including disability adjustments and international-student needs).
- Budgeting pressures for fees, materials, labs and pracs, particularly for international students (noting similar effects on domestic students).
- Current wording of "More information about enrolments will be sent to you prior to them opening" reads as open-ended and hampers planning.

What those students seem to be asking for now

Students seek:

- 1. A revised timeline, with specific dates (or date ranges) for:
 - a. release of their study plans(as the original September proposed deadline is no longer possible);
 - publication of 2026 course availability and course outlines ASAP or an exact date;
 and
 - c. enrolment opening exact date with where to find help if stuck.
- 2. A short note on any new enrolment-support measures for AU courses.



Details of targeted initiatives for cohorts requiring additional support (online and in-person channels; service hours; disability adjustments; and tailored international-student advice).

Next steps

Council has acknowledged the issues raised by students above and writes to request:

- That the University answer the questions set out above so we can promptly passing on some of these information; and
- 2. That the University provide periodic updates to Council on study plans and enrolment arrangements, to support effective dissemination. We understand the IMO's competing priorities arising from the merger; if meetings are not feasible, a short-written update addressing student concerns raised through Council would be greatly appreciated; And
- 3. The Council has observed inconsistency of some of the critical matters such as some students received communication around when enrolment will be open, but some didn't. Others might already have their study plan, but the rest haven't. Double degrees are not out yet but single degrees are out etc. The Council wish to ask for a formal linier chain of communication that has come out so far so we can then bring these students all on to the same page, where possible, and other clubs or interested non-officer students as well.

To be clear, while students have complained about the matters above, this letter is a formal raising of those issues by the SRC on their behalf. We appreciate the frustration form students, and equally so we appreciate that advocating and conveying student views as an intermediate is part of our role, and we value the ongoing partnership with the university aimed at a better student experience. We also acknowledge the amout of planning that goes into 60k study plans.



We are ready to assist with briefing and dissemination and look forward to hearing form you.
