Postgraduate Coursework Report - SRC Update

Student Grade Discrepancies and Support Recommendations

As observed in last academic periods, a significant number of postgraduate coursework students have encountered issues related to incorrect grade reporting. This situation has had both academic and psychological consequences on students. I would like to highlight the matter and propose a few recommendations for the University's consideration.

Key Issues Identified:

- · Several students have reported failing grades that were later found to be the result of administrative errors—specifically, the failure to update correct marks in the system.
- These discrepancies cause undue mental stress and anxiety for students, particularly those relying on satisfactory academic performance to maintain scholarships or meet visa conditions.
- The process of resolving such issues often requires students to contact course coordinators, the Faculty of SET, and administrative staff multiple times, leading to delays and communication gaps.
- · In most cases, the actual assessments have been passed, but results were not correctly reflected in the system.

Recommendations:

- · Grade Verification Protocol: Implement a robust grade verification process before results are released to ensure data accuracy across MyUni and Access Adelaide platforms.
- · Provision of Exam Resources: Encourage all course coordinators to provide high-quality, standardized study materials—including sample questions, clear rubrics, and revision guidelines—to support student exam preparation.
- · Scholarship Retention Safeguards: In cases where grade errors are identified and corrected, students should not face unintended consequences such as the complete loss of scholarships. Instead of revoking the entire scholarship due to failure in a single subject, it is recommended that the scholarship continue for the subjects in which the student has passed. This approach ensures fairness and continued support for academic progress.

I respectfully urge the University to consider these suggestions as part of its continuous improvement efforts in supporting postgraduate coursework students.
