2. Confirmation of Previous Minutes

Aiden Wang advised that the minutes of the 4 June 2025 meeting have not yet been made available, despite his repeated follow-ups. These minutes were the responsibility of the then-General Secretary, Edward Archer, who has failed to provide them to either Aiden or to Kim (SRC Administrator), as required.

Aiden noted that he has proactively chased this up with YouX staff, and it is disappointing that the former General Secretary did not fulfil such obligation of his role. Despite reminders, the minutes remain outstanding, which has delayed proper confirmation. This is also the reason why on the YouX website, the minutes has not been uploaded.

Aiden stated that unless these minutes are received and processed appropriately, the Council may need to consider alternative measures, including a collective resolution to recall and ratify the content of the meeting if necessary.

Motion: That Aiden Wang will continue to inquire with YouX about the previous minuets, and the ones earlier in the year(as they are currently missing on YouX website).

5. New Members

Aiden communicates that the first round of casual vacancy had opened previously. Aiden has made an inquiry to Edward Archer regarding applications that have been made; however, Edward Archer has not replied to that email.

Adrian asks if any candidates are known, due to the importance of filling the vacancies and it has been quite a while now.

Aiden states that the only known candidate is a Post Graduate HDR Officer candidate and Environmental Officer Candidate who CC'd the President into the nomination email, that all other applicants are unknown due to Edwards failure to fulfill his duties to provide such info to the council, that the executive have convened and passed a motion that it will extend applications one more week as it is unknown if the two candidates are the only person to have applied, and that the Application for that round closed 2 August.

Adrian seeks clarification on the extension for transparency and good governance.

Aiden notes to council that the extension for that round was due to fairness and to provide an opportunity to members who have applied before to apply again(if it has not been made aware to the President), this time in the official SRC President Email Address for transparency.

Aiden mentions that the executive will commence interviews very shortly, that on 9 August another round of casual vacancies will close as has been communicated on the Facebook page, and that this will be conducted by the executive and presented to council.

Jarrod Xia disconnects from the meeting.

Sam asks to clarify if the official email accounts should have been used for casual vacancy nominations from the beginning.

Aiden noted that for casual vacancies, it is important that the official SRC president account is used, rather than individual student accounts. good governance requires official accounts to be used so that it is transparent and accountable, and does not cause delay for council, as is currently occurring.

Aiden notes that this is also why for official council communications, the SRC President Email is used for communication to students or get into contact with students.

7. Office Bearer Reports Office Bearer Reports

7.1. President

Report taken as read.

Aiden notes that international students are being assaulted across Australia. Club submissions have been received corroborating this; these have been referred to the University, and YouX. Still, it is important for himself to address this systematic issue. It is unfortunate and should not be occurring. Aiden has issued letters and will issue a letter in his personal capacity. Aiden calls the council to support this decision, with subsequent drafts to be communicated with the Executive.

Aiden encourages students, not just international but domestic as well, that if they have been hurt or impacted on campus, to please reach out to himself and other official services on campus. Aiden condemns any harmful behaviours and reiterates that every student has the right to feel safe on campus at all times.

Aiden notes that recently an Instagram account has come to his attention due to an enquiry form a student: au.src.

Aiden confirms that this is not an account owned by the SRC and has also obtained confirmation that YouX marketing is unaware of the account. YouX suspects that this might be suspicious activity, and the matter will be looked into. Aiden will provide information to council in due course.

The council conveys its concern on this matter.

Motion: That the President investigates the suspicious social media account purporting to represent the SRC, and liaises with YouX staff to prevent confusion arising among students who may mistakenly believe it to be official. The Council confirms that this account is not, to the knowledge of the SRC, affiliated with or authorised by the SRC. The President shall provide updates to Council as this matter progresses.
