Waite Campus Rainbow Room SRC Petition & Survey

Purpose:

Recently, I received an email from a student informing me that there are rumours circulating that there is interest in developing a Rainbow Room at the Waite campus. In their email, they expressed the desire for there to be a safe space for the LGBTQIA+ community on-campus but that they would likely require help from both the Pride Club and SRC. The Dr Duncan Memorial Room/Rainbow Room at the North Terrace campus has undeniably provided a safe space for many students to experiment with their identity as well as connect with peers who are able to help them on their journey of self-discovery. An LGBTQIA+ staff member who teaches at Waite has openly expressed their view that more support needs to be offered to Waite students who may not feel comfortable with coming out. It is highly likely that a Waite Rainbow Room would be able to help provide this support in tandem with there being an increased LGBTQIA+ presence at the Waite campus.
