Oscar Zi Shao Ong said that according to an email he sent to directors who voted against these motions last meeting, he thinks it would be important to note down the reason why directors are not supporting a resolution in the minutes to clarify it to students for transparency.

Felix Eldridge asked whether directors need to justify voting against trivial motions, Oscar Zi Shao Ong confirmed and said that the reason for voting against should be explained for the purpose of transparency.

Michael Physick asked whether the reason is captured in the discussion and would be in the minutes, to which Oscar Zi Shao Ong answered that the reasons are not currently explicitly stated in the minutes.

7. AUU President's Report*

Chair was passed to Isaac Trumble at 6:03pm.

Oscar Zi Shao Ong went over his report.

Grace Franco asked whether he is doing anything in the international students space. Oscar Zi Shao Ong outlined the \$500 grants, where clubs could apply for to create events for international students, stating that the majority of engagement would be through clubs. Grace Franco asked about strategies for encouraging them to purchase memberships.

Gary Sutherland said while offshore students likely won't take up a membership as most of the benefits provided are onshore, the AUU would be focusing on recruiting more students to recover from losses in the last few years.

Chair was passed to Oscar Zi Shao Ong at 6:13pm.

9. Clubs Administration Policy

Oscar Zi Shao Ong outlined that the reason for adding 6.11.4 is to unify the standard for rejecting clubs between EOI and provisional registration and adding 11.5 is to make sure clubs carry out the function they intended or applied for.

Felix Eldridge asked if this was prompted by an event. Oscar Zi Shao Ong said that he just wanted to make sure the rules are up to the same standard, and there has not been a specific incident.

Rebecca Etienne asked whether this would prevent clubs from collaborating, as often these collaborations would not strictly follow the aims and objectives states in the club constitution.

Isaac Trumble said that this is not the intent of clause 11.5, as collaboration would still serve the purpose of clubs, and a deviation from it would be a lot more recognisable. He gave a fictional example of the UofA Totally Cooked club rebranding themselves as a radical right-wing club to illustrate a deviation from the club's proposed activities and purposes.

Grace Franco asked about the aim of the addition. Oscar Zi Shao Ong said that since the clause is added under club conducts, it will give clubs committee power to intervene. Luke Allen further added that if there is no metric given to govern club's direction, then there is no point of assessing club's registration as they might choose to change it as they please.

Felix Eldridge asked whether consultations were conducted through clubs committee, Oscar Zi Shao Ong said that this arose from a discussion between him and Luke Allen.

Grace Franco asked for the person to determine "proposed activities", Oscar Zi Shao Ong said its part of the process of clubs registration. Grace Franco asked whether existing clubs could still carry out events that are not explicitly stated in their aims and objective. Isaac Trumble stated that "activities" in the clause is not referring to the specific events clubs would plan, but rather the general expected actions of the club. Hence, he said that clubs don't have to list every possible activities they might arrange in the future, and the clause is mainly to prevent clubs from radically changing their direction.

Felix Eldridge said that the "submit to AUU" part of the clause could be clarified further by including the person responsible, whether the clubs admin or clubs committee, to prevent confusion. Isaac Trumble and Oscar Zi Shao Ong felt that this would be a very low-risk event and is not quite arguable.

Felix Eldridge asked about potential retributions of a rule breach. Oscar Zi Shao Ong cited clause 7 which outlined actions clubs committee could take, including freezing them.

Isaac Trumble moved the original motion. Yi-Ruei (Esther) Hung seconded it.

Felix Eldridge proposed an amendment to the motion: "Clubs must not significantly deviate from its proposed activities and purpose as submitted to the clubs committee. Any significant deviation from the

clubs proposed activities and purposes must be submitted to the clubs committee for approval."

The motion was not amendable by the mover or seconder.

1. O'Week

It was a fantastic O'Week, with a 1200+ new memberships already bought on Day 2. I have been able to speak to a lot of new students and clubs. I am excited to welcome our international students to our campus after two years (1167 as of 17/02/22). I also spoke in the Welcome Event of international students, alongside PVCI, Jacqueline Lo.

2. Student Engagement Committee Meeting

The meeting is on next Tuesday, I will provide a summary in the meeting.

3. SRC

The recent conduct of the SRC has been disappointing.

SRC Meeting

The SRC's first meeting's legality was questionable due to the serious lack of organisation and zoom was plagued with technological issues. The majority of the meeting were inaudible in zoom.

Stifling Freedom of Speech

It has been brought to my attention that the SRC has been "hiding" facebook comments. See below:

You don't know what the difference between "Far right" and "Center right" or even Center is.

Counter Guide

The counter guide included a section from the National Union of Students Incorporated, which in turn prohibits the AUU to reimburse the cost spent. Furthermore, The SRC counter guide has comments that might potentially be defamatory, notably, the one that I am most concerned about, is the claim that Counselling Services has a wait time of a month and university sacking six staff. The resources in Counselling Support have not decreased but has increased in FTE and appointments are available within a week (as of 24/02/22) (sooner for emergency appointments based on triage). The frivolous claims have serious implications if the counter guide is distributed to students, especially during O'Week when first years (including international

students) are coming to campus the very first time. Mental health is an extremely serious issue and should not be politicised, the pandemic already has a profound impact on mental health, especially international students leaving their family the first time (Not to mention the already existing cultural barriers for international students). The claim will discourage students to reach out to counselling support. I do not and will never tolerate any attempts to introduce barriers to accessing mental health.

4. Student Care Board Meeting

I chaired the first student care board meeting and we discussed responsibilities of student care. We welcomed Ruth as a valuable addition to our Student Care EWO team. Important supports are continuously provided by our hardworking student care team. Breakfast club will continue as Semester One commences, we are excited to hear there has been a lot of enquiries during O'Week.

5. Clubs Committee Meeting

Luke has scheduled the next Clubs Committee meeting.

6. Meetings with the Executive Officer

I have been regularly meeting up with Gary about the progress of O'Week preparations.

7. Ukraine-Russia

I have reached out to university to ensure students from Ukraine and Russia are well supported through this difficult time. The university don't currently have any students from the Ukraine. Support messages to students from Russia has been sent.

8. Media Enquiry

I have been approached by The Advertiser to make a comment regarding the SRC. I worked with Simone and Kearin and coordinated a respond back to the SRC.

9. Consultation with Roseworthy

I have been in continuing consultation with Roseworthy students regarding AUU and the wider university issues. I have actioned some of those concerns with relevant AUU staff.
