5. AUU President's Report*

Chair was passed to Luke Allen at 5:35pm.

Oscar Zi Shao Ong went through the report, reminding directors that the National Student Safety Survey is happening soon.

Grace Atta entered via Zoom at 5:39pm.

Rebecca Etienne asked whether the disclosure training would be available to other student leaders. Oscar Zi Shao Ong said that the university is trying to add more sessions. Michael Physick confirmed that additional sessions are being arranged.

Grace Atta asked whether SRC funding was frozen indefinitely or on conditions. Oscar Zi Shao Ong said that it is frozen temporary pending on SRC representative's attendance to the mediation meeting arranged

at 24th of March. He noted that the times has changed to 11:30am upon request of the SRC General Secretary.

Merlin Wang entered via Zoom at 5:45pm.

Felix Eldridge asked about the use of "questionable legality" for SRC meeting. Oscar Zi Shao Ong cited extreme audio issues and questioned the legitimacy of votes for people attended via Zoom.

Felix Eldridge commented on the use of "unanimous decision" in the communication to the SRC fund freeze, since the board did not declassify the fact that it was passed unanimously.

Oscar Zi Shao Ong said that narrative matters here to clarify biased views on how board decisions are made by a few people.

Felix Eldridge reemphasized that the board was not consulted on this decision, and it would be good to notify people in advance. Oscar Zi Shao Ong said that he thinks it is based on the chair's judgement to make sure the reputation of AUU is intact. He added that it is important to highlight that the decision to cut funding is not political.

Felix Eldridge asked whether it was foreseeable that the SRC would leak information on funding cut. Oscar Zi Shao Ong said that he sent the email based on good faith.

Chair was passed to Oscar Zi Shao Ong at 5:52pm.



1. NSSS Survey Results

The NSSS survey was released on March 23. Additional counselling support is provided because it could be a triggering event for students. You can find my respond through a statement in Appendix I.



2. Student Engagement Committee Meeting

The following items were discussed:

Consent Matters Training

"Commencing students are auto-enrolled into Consent Matters training, and there had been around 80% complete this last year. The University will follow up with those students who haven't undertaken the training. All student are expected to undertake this training." As per my suggestion, the university is looking into making the training compulsory.

I've asked additional SASH training to be provided, especially during the release of NSSS results.

Update on Organisational Sustainability Program

"Martin said that recruitment was well underway at present for the many new roles, with 28 March as the go live for the new structure. Within DASE there were 60 roles being filled. Martin reiterated that students shouldn't see an impact on their experience when go-live occurs, and there was a lot of work currently going on behind the scenes.

Jennie advised that the Vice-Chancellor, after a period of consultation, had sent through an email to students and staff about the names for the two new Faculties. They would be called:

- Faculty of Arts, Business, Law and Economics (ABLE)
- Faculty of Sciences, Engineering and Technology (SET)

Not all signage will be ready for March 28. This will be implemented over time.

Martin said that the locations of teams and faculty offices were being worked out, with a large number of staff likely to move location over coming months.

Jennie said that there were no plans as yet around restructures potentially affecting schools, courses, programs or academic staff. These discussions would occur, but not until the new faculty structure was in place." The next SEC meeting is on 13th April.

3. SRC

It has been disappointing to see the SRC has continued to articulate false claims and has expanded their claims from "a month" to "months" waiting period. Mental health shouldn't be politised, this is a disgusting act as it discourages students to seek help, as confirmed through conversations with university and students.

Wood is not convinced.

"The state of things at Adelaide now are already bad enough, with months-long waits for student counselling, a library service in decline and casual tutors who are severely overworked and underpaid with no job security," he said.

4. Clubs Committee

5. Meetings with the Executive Officer

I have been regularly meeting up with Gary about the various issues.

6. Media Enquiry

I have been approached by ABC and the Advertiser to make comments on various issues. I worked with Simone and Kearin and coordinated a respond back to them.

7. Consultation with Roseworthy

Through consultations with students in Roseworthy, they are highly supportive for us to continue student ambassador and have raised concerns of workload. I have relayed the concerns back to our staff and a few improvements were achieved, including providing more support and information from our staff in North Terrace. I will report back more as progress is made on this item. A new student ambassador has also been appointed recently.

8. Student ID Issue

A student raised an issue about the student ID being printed wrongly. I have raised it to university and its now resolved.

9. Infrastructure Issue

A student raised the air conditioning is leaking water at room 307, Schulz Building. The issue is now resolved.

AUU response to release of 2021 National Student Safety survey results

Today the University released its results from the National Student Safety Survey (NSSS), with 1373 University of Adelaide students participating in the survey. Clubs and societies, events and spaces have been identified as the third most reported location where a sexual assault or sexual harassment (SASH) incident is likely to occur at our University.

The AUU is funded by the University to provide an administrative framework for Clubs so they can function autonomously and access financial support. Given the contribution Clubs make to campus life, we are incredibly passionate about advocating for their best interests.

We take SASH issues very seriously and have undertaken a range of important initiatives, including:

- 1. Advocating and achieving the relocation of the Security Office to a more accessible location
- Providing compulsory First Responder training for all student leaders, including AUU Board Directors, SRC officer bearers, On Dit Directors and Clubs Executives, to assist them to deal with disclosures and provide support to victims
- 3. Making Risk Assessments compulsory for Clubs for any event(s) that are attended by more than 100 people and/or people who are under 18 years of age. This is also compulsory for events taking place outside of the campus.

Despite these significant steps forward, there is still much more that needs to be done. That's why we are continuing to work with the University to deliver the following essential outcomes for students:

- 1. Compulsory Consent Matters course completion and First Responder training for all students
- 2. Making First Responder training available at least once per month on an ongoing basis
- 3. Improving the promotion of University support and reporting channels to increase student awareness
- 4. Lobbying the University to take on primary responsibility for all university-related student conduct, and more specifically for club activities and events. Student led activities are a fundamental part of student life and University experience. As such, we believe it is essential that the University takes full responsibility for the management of student behaviour and conduct in all facets of student life, not just inside the classroom. Responsibility must not be passed to the AUU or our small student-led clubs and groups who lack the required resources and expertise to assess and manage such issues.

We will continue to work with the University closely and hold them accountable in efforts of preventing SASH and supporting SASH victims.
