8. Rule Concerning In Camera*

1. Sexual Misconduct Policy

I met with the university regarding the policy and have raised my concerns on several areas:

2. Open Day

l organised several directors, including myself to volunteer and help out during open day. It was a great opportunity to interact with prospective students.

3. Meetings with the Executive Officer

I have been regularly meeting up with Gary about the various issues.

4. Media Enquiry

I have been approached by the numerous media outlet to make comments on various issues. I worked with Simone, Summa (the RO) and Kearin and coordinated a respond back to them.

5. Food Truck Feast

It was a successful event, and I was pleased to hear a lot of positive feedbacks from our students. Thanks to the hard work of the YouX staff in making the event series a huge success!

6. Student Led Teaching Award

Current teaching awards do not allow students to nominate their lecturers. I intend to restart the conversation around the student led teaching award in making it a reality again.



7. Clubs Enquiries

I have assisted with several clubs enquiries regarding equipments and grants.

8. Bachelor of Teaching (Secondary)/Bachelor of Mathematical and Computer Sciences

Students of 2020 Bachelor of Teaching (Secondary)/Bachelor of Mathematical and Computer Sciences have raised concerns to me that despite not listed in their study plan (attached) but listed in Bachelor of Mathematical and Computer Sciences (BMaCompSc)

(https://calendar.adelaide.edu.au/aprcw/2020/bscms_bscm%26cs), they are expected to study MATHS 3021 Capstone Project in Mathematical Sciences III (as per instruction by askSET after they approached ABLE) to graduate. The university investigated the issue and can confirm that MATHS 3021 is not compulsory for Bachelor of Teaching (Secondary)/Bachelor of Mathematical and Computer Sciences students. This will be circulated throughout the SET Student Success team in case students present in the coming days. Any students who have contacted either SET or ABLE over the last couple of days via email will be advised of this.

9. Clubs Committee Meeting

Luke chaired another Clubs Committee meeting.

10. Hub Bathroom

A student raised to me that a bathroom in the hub requires cleaning urgently. I raised the issue to the university and it was cleaned in a short period of time.

11. Clubs Trivia Night

I attended the trivia night and it was well-attended by clubs.

12. Waite Campus Access

Several students have raised that they no longer got access to Waite Campus. I raised the issue to the university and confirmed they have access. I have directed to check with security as it may be an issue with their student cards.

13. Clubs Consultation re Amending Membership Requirements

Clubs are funded by SSAF and therefore it will be important to ensure majority of the club members are UofA students. We initiated a consultation survey to garner views on the matter.

14. On Dit Article 'For Palestine, there is No Ceasefire'

There has been a significant impact on student welfare due to the article written by On Dit editor, Habibah. I moved to establish the independent committee shortly after to investigate the matter and I thank the speedy response from directors in concurring with my motion. The report will be tabled in the meeting for further discussion. Habibah has been invited to come to the meeting in person.

I had several discussions with the university (Acting VC and DVCA) on the matter. My comment was also include in the Acting VC email to all students: "Oscar Ong, President of YouX, is supportive of the concerns raised about the article and will raise these directly with the On Dit editorial team with a view to establishing better editorial practices in the future.".

The Committee investigated the conduct of the AUSM Director in relation to breaches of one rule of the Rules concerning Student Media, and one clause of the YouX AUU Constitution, these were:

Rules Concerning Student Media

Rule 4

AUSM Director Obligations AUSM Directors must not:

4.1. Be found by a court of law to have broken any law in connection with their duties as AUSM Directors.

4.2. Misappropriate any amount of Student Media funding.

4.3. Make significant deviations from the publication schedule agreed to in pursuance with Clause 13.3. of this Rule, without reasonable excuse or appropriate consultation.

4.4. Breach a resolution of the Student Media Tribunal.

Finding: the Committee found that the student did not breach any of their obligations as AUSM Director in relation to Rule 4.

YouX AUU Constitution

Establishment & Objects

This body exists primarily to: 1.2.2 to further the welfare of Students and Members;

Finding: The Committee found that the AUSM Director has breached this clause of the Constitution.



Key notes and comments:

- There was no specific finding of a breach resulting from the initial article For Palestine, there is No Ceasefire.
- Investigation primarily focussed on the conduct and behaviour of the AUSM Director after the article was published.
- Conduct at the SRC meeting by the AUSM Director was disrespectful and dismissive of students with opposing views.
- Despite numerous opportunities to clarify her position and dispel any misinterpretation of threats to student welfare, the AUSM Director has continued to use language in public forums that can be clearly construed to action that may threaten the welfare of students.
- The Committee believes that a reasonable minded observer would form the view that this continued conduct could threaten student welfare.
- While the AUSM Director is free to voice her views in a private capacity, as an elected representative the Committee believes she is subject to same organisational values as all other representatives and employees of YouX.
- Any threat to student welfare is a matter of grave concern, and must not be tolerated.
- The YouX Board must determine whether it is tenable for Habibah for her to continue serving as an AUSM Director of YouX.
- YouX has a responsibility to ensure all students feel safe to attend University despite differences they may have.
