Chair passed to John Arputharaj at 5.33pm.

\$10,000 of club grants were exhausted this year. Oscar Zi Shao Ong asked Gary Sutherland to reallocate \$10,000 to this year's club grants and \$5,000 to the breakfast club. There is now a total of \$100,000 in club grants this year.

There will be a \$286,452 increase in the SSAF to YouX, which is still waiting on approval from the Vice Chancellor. This will allow an additional \$20,000 funding in club grants and \$10,000 funding for the breakfast club to continue providing four days of free breakfast. He also noted any rechannelling of funding could have the effect of lowering YouX funding.

The intention to increase club student membership percentage w	

The intention to increase club student membership percentage was reviewed. It was suggested to raise this percentage since clubs are funded by the SSAF. Hence, making sure club money is spent on university students and that actions can be taken if any sexual misconduct occurs in clubs.

The 2022 membership consultation survey results showed a negative reaction raising club university student and alumni membership percentages.

Oscar Zi Shao Ong noted there are several misrepresentations in the On Dit article including misconceptions about how 75% of membership must be University of Adelaide students, where there is a minimum of 51% as the University's students and 24% as the University's alumni. The other misrepresentation was that the report was made public too.

Luke Allen suggested that perhaps AGM attendance may be capped at a 75% University student attendance.

Oscar Zi Shao Ong asked John Arputharaj to create a schedule for the meetings with club presidents to be published at the start of the year for presidents' reference.

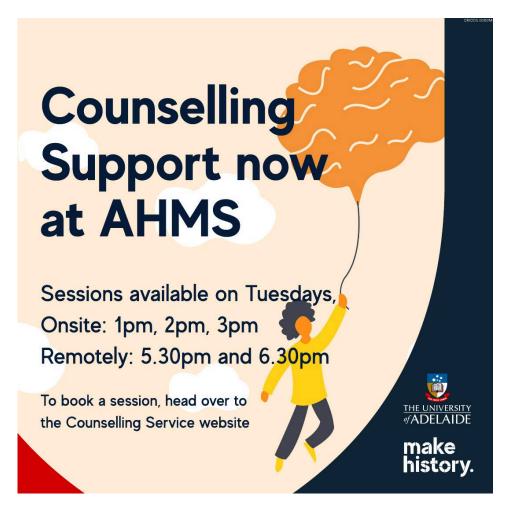
