# YouX President Report

Dear Directors, I wish you all have a good break. Although we are still in the break, there are still some important things that have happened since last meeting.

## **SRC Update:**

As you may aware that Cyrus Kelly has lodged a legal challenge on the Election Regulation that was passed by the SRC on 31<sup>st</sup> November 2023. This challenge aims to overturn SRC's Election Regulation. As SRC is an affiliate body of YouX, I have been closely working with the EO, SRC Acting President Aiden Zeyang Wang to try to find a solution for it. YouX is also seeking for legal advice to help the SRC to go through this challenging period.

## **Student Reps Exposure:**

YouX and SRC Reps have limited exposure, most students do not even know who we are and never contact us for assistance. This is very concerning, I have met Kearin to discuss this issue and hopefully this year student reps will have more chances to directly contact with the students and I have also asked him to consider to increase our exposure on YouX social media accounts. I also would like to strongly advise our directors to update their profiles on YouX website so students can know us better.

## **Clubs Committee Meeting:**

The first Clubs Committee Meeting was held on 17<sup>th</sup> January, only one club got EOI approval and only one club got their provisional registration. In this meeting, it was clearly reflected that some parts our Committee Rules are unclear and may have contradictions with the resolutions that were passed by YouX. However, as our Executive and in-camera meeting minutes are confidential, it may lead to confusions for the clubs committee to interpret their decision. Therefore, a few changes were made to address this issue which will be discussed later in this meeting.

## **Merger Discussion with USASA:**

USASA has requested to meet with YouX to discuss the merger between YouX and USASA. However, I will not formally meet them before the YouX Board having a formal discussion about the potential models of the combined student organisation. If you have any ideas, please feel free to share with me.

The email concerned a final notice to be lodged with the Magistrates Court against the SRC on the 27th of December 2023 on Monetary and other claims regarding the election regulation enacted in 2023.

Considering this might pose a risk to YouX, I immediately informed Merlin, Katheryn, and Kim about this complaint and have been diligently working to ensure this matter is handled with care and in a proper manner.
