# 1. SRC Meeting

The SRC reconvened for their first meeting of 2023 on the 8th of February, papers from this meeting can be provided to Board Directors if they wish and will be uploaded to the YouX website as soon as possible. Please see below motions which were successfully passed at this meeting:

Environment NDA

- 1. The SRC supports the March 17 National Day of Action and it's demands
- 2. The SRC will promote the NDA at it's O'Week stall
- 3. The SRC will co-host the Facebook event for the Adelaide action and promote the event on Facebook
- 4. SRC representatives who support this motion are encouraged to attend the event and help with its online promotion

Invasion Day

- 1. The SRC condemns the celebration of Australia Day on January 26 and recognises January 26 as Invasion Day/Survival Day
- 2. The SRC condemns current and previous state and federal Governments for their severe inaction on Indigenous rights

### 3. Committees

I participated in a university *end-user device management strategy workshop*, which covered user experiences and access to applications and devices used at uni.

The university is also currently conducting co-design sessions for their *Education for a Digital World strategy project*. This strategy intends to provide direction and distinction in the university's work in the coming years, with a strong focus on enriching the student experience. I am participating in this project alongside the YouX President.

The Student Engagement Committee will also commence work in week 1 of the semester. The SRC representatives on this committee include myself, the Education Officer, the International Student Officer, the Postgraduate (Research) Officer, the Roseworthy Officer and the Waite Officer.

### 4. University Health Practice changes

Last Monday an announcement was made regarding the reintroduction of gap payments at the University Health Clinic. A \$10 fee is now payable for all student appointments at the clinic. Positively, this has resulted in a reduction of appointment fees for international students who do not have a medicare card. Both the YouX President and I have met with the university and Better Medical to discuss how this will impact students - the clinic has confirmed discretional bulk billing will remain available. I released a statement about this, as these changes were not immediately communicated by Better Medical and the University. Numerous concerns have been raised about this which I am hopeful the SRC and YouX can work to action.

### YouX President's Report:

1. Meetings With the EO

I have met with Gary and discussed various issues throughout the past month.

# 2. Student Care

I was privileged to chair my fist student care board meeting earlier this month. It was rewarding to be presented with the latest update regarding the operations of student care. I was also informed that student care will be expanding their team through the employment of another experienced advisor.

# 3. Education for a Digital World Co-Design Workshop

I have been fortunate to attend two out of the five digital world Co-Design workshop sessions. It has been an interesting and insightful process. I have been privileged to be offered the chance to present the students perspective on the current education experience and offer insight into what students may be looking for ten years from now. I hope to represent and express student needs, requirements, and desires as effectively as possible in the remaining workshops.

4. Unicare Gap Fee

I have recently been in consultation with Better Medical and several University representatives from the student engagement committee regarding changes to the healthcare system currently provided by Better Medical. During the consultation, it was revealed that the government have made changes to Medicare which has resulted in restrictions to bulk billing. As such, general practitioners (GP's) are struggling to maintain financial viability. This has resulted in Better Medical, the owners of the University Health Practice, revisiting the introduction of a gap fee. The proposed gap fee is a "heavily discounted" \$10 for all students, including

international students, who had to pay just over \$11 previously. Despite the introduction of the gap fee's, better health has maintained that they will offer discretional bulk billing for students who demonstrate obvious need

I would like to note that whilst the introduction of a gap fee is not ideal, the alternative of no gap fee would likely result in closure of the health practice. This would result in a significant impact to the campus health services as there would no longer be access to an on-campus health practice.

Further to the consultation with Better medical and the University, I have been engaged in communications with students who have raised concerns regarding the required method of payment currently dictated.

I have been informed that at present, students are required to pay the full amount for the medical consultation, after which, they are refunded by Medicare. This presents significant difficulties to students as the cost of a consultation can range between 30 to 50 percent of a student's AUS Study allowance.

I have since taken this issue up with the university and hope that a solution can be found wherein students are only charged the \$10 gap fee.

# 5. SRC Activity

The SRC have held their first meeting of the year that saw a variety of motions being passed. As per Georgia Thomas's report, directors will note that the SRC will be present at YouX events on several University campuses during O'week.

### 6. Clubs Committee

I recently attended the first clubs committee meeting of the year. It was pleasing to facilitate the approvals of several expressions of interest, a swathe of grant applications and two applications for full registration.

The minor grant structure was also revisited, and several changes were made, resulting in increases to the maximum amount event funding that clubs can apply for.
